Furthermore, SAKOV acts in an advisory role and endeavours to provide responsible guidelines and recommendations – also in terms of salaries and service contracts of organists.

Tutorial courses are offered annually in the thirteen SAKOV regions in Southern Africa and Namibia, and special projects such as publications and CDs are launched.
